II. Definitions of Terms

1. In these Price Conditions, the following terms are used according to the meanings as detailed:
 - 1.1. Entrance Price
Consideration that shall be paid in order to obtain admission, not excluding other forms of consideration.
 - 1.2. Admission Ticket
Entitles to a one-time visit to the WasserSpiegel Museum for one or multiple people.
 - 1.3. Family
Parent or parents belonging to the same family (also step-, adoptive or foster parents) as well as their children for whom a family allowance is provided in accordance with the Austrian Family Benefits Act ("Familienlastenausgleichsgesetz", 1967), or for those children for whom no right to a family allowance exists since a right to assistance of similar nature exists in a foreign country.
Provisions of the Austrian federal law pertaining to registered partnerships ("Eingetragene Partnerschaft-Gesetz" – EPG), Federal Law Gazette (BGBl.) No. 135/2009 will be applied correspondingly.
 - 1.4. Combo Tickets
Serve for use of the MönchsbergAufzug Lift, the FestungsBahn Funicular and admission to the WasserSpiegel Museum.
 - 1.5. Children
Children are persons ages 6 to 14 (up to the day prior to their 15th birthday).

II. Definitions of Terms

- 1.6. People with handicaps are persons,
- who are able to present a disability card according to §40 of the Austrian Disability Act (“Bundesbehindertengesetz”) with the endorsement “The holder of this card is entitled to claim a fare discount per the Austrian Disability Act, or
 - who are able to present evidence of a degree of disability or diminution of earning capacity of at least 50%, or
 - who are able to present a disability card according to §40 of the Austrian Disability Act with official confirmation of diminished earning capacity of at least 50%, or
 - who claim supplemental family assistance according to §8 par. 4 and 7 of the Family Benefits Act 1967, insofar as there has been a determination of diminished earning capacity of at least 50%, or of prospective long-term inability to independently provide for themselves, or
 - who claim a care allowance, care bonus, allowance for the blind or comparable support, or
 - who claim an invalidity pension (reduction of earning capacity of at least 50%) documented by means of attestation from the applicable social insurance provider, federal social services or the payment authority, or who are eligible for benefits due to a mobility impairment of at least 50%, or
 - who are entitled to supportive care according to the Austrian Veterans Care Act (“Heeresversorgungsgesetz”) with a diminution of earning capacity of at least 50%, or who are from other countries and likewise entitled to such supportive care, subject to production of a disability card similar in nature which clearly details the first and last names, place of residence and date of birth, along with a diminution of earning capacity of at least 50%.
- In case of doubt, the claimant must present qualifying documentation (e.g. disability card according to §40 of the Austrian Disability Act, or an equivalent document, or a [provisional] “ÖBB-ÖSTERREICHCARD Spezial” in combination with a photo ID showing the claimant’s age).

II. Definitions of Terms

- 1.7. School Children
- enrolled pupils at a public school or an Austrian school accorded public status, or
 - enrolled pupils attending an equivalent school in a foreign country close to the Austrian border which is more convenient to reach than an Austrian school, pursuant to approval by the public school authorities if the child is still of compulsory school age, or
 - pupils who attend a school which falls under the provisions pertaining to training for nursing professions, medical-technical professions or paramedic services, or
 - enrolled pupils of an Austrian school which, in accordance with § 12 of the Compulsory Schooling Act (“Schulpflichtgesetz”, Austrian Law Gazette No. 76/1985), is certified as suitable for fulfilment of compulsory schooling requirements, or
 - enrolled pupils of an Austrian private school that has been granted a publicly regulated school designation (§11 of the Private School Act, “Privatschulgesetz”, Austrian Law Gazette No. 244/1962).

III. Price Conditions

2. **Opening Times**

Precise opening and closing times are published on the homepage of Salzburg AG Tourismus GmbH.

Salzburg AG Tourismus has the right to extend or shorten its published hours of operation.

3. **Admission Tickets**

3.1. Admission tickets are valid on the day they are redeemed for admission to the WasserSpiegel Museum

3.2. The admission ticket must be presented or handed over for inspection immediately upon the request of any authorized employee; If the visitor is unable to present a valid admission ticket for inspection, they shall pay double the standard entrance price. Upon demand, the admission ticket must be relinquished upon conclusion of the visit.

3.3. An admission ticket is invalid if

- the contents thereof have been altered without authorization, or
- due to its condition its validity cannot be verified, or
- it does not meet the price conditions in some other way, or it is being used contrary to the price conditions, or
- it is only valid in combination with an ID and the applicable ID cannot be produced or is invalid.

Invalid admission tickets will be confiscated by the employee authorized to conduct the ticket inspection.

4. **Admission Prices**

The admission prices for the WasserSpiegel Museum are shown in the Price Schedule.

If admission proves impossible due to causes for which the WasserSpiegel bears responsibility, the entrance price will be refunded in full.

If admission does not occur due to reasons for which the visitor bears responsibility, the visitor will have no right to a refund.

IV. Price Discounts

- 5. Children**
Accompanied children ages 5 and under, with no more than two children per chaperone, receive free admission. Children ages 6 to 14 (until one day prior to their 15th birthday) are given the children's price.
- 6. Groups**
The discounted admission price is granted if the prescribed price for at least 10 participants is paid collectively by a single passenger.
- 7. Youth Groups**
The discounted admission price for children, pupils and youths is granted if the prescribed admission price for at least 10 participants is paid collectively by a single person.
The group must be supervised by an authorized chaperone.
This chaperone receives free admission.
- 8. Families**
The discounted admission price for families is granted when at least one parent rides together with at least one child.
- 9. People with Handicaps**
People with handicaps and/or restricted mobility will receive discounted tickets. An attendant will only be granted a discount insofar as they push the person in a wheelchair and/or the disability card indicates a need for the attendant.

V. Miscellaneous

10. Companion Animals

Companion animals are not permitted at the WasserSpiegel Museum.

11. Hand Luggage

Temporary storage for hand luggage, regardless of form or size, is not available.
